

## Referrals

Referrals come from the local authority. Lyndale is able to provide support to service users who are receiving 117 Aftercare, on Section 17 leave, a supervised discharge, Guardianship order or Community Treatment Orders. Lyndale cannot support and accommodate persons who require nursing care that cannot be managed by the community district nurse service. Before service users decide to move in to Lyndale, an assessment will be carried out by the Registered Manager from Lyndale with the service user and any other person the service user would like present. This assessment will form the basis of the service user plan that will be devised and formulated with the service user together with their keyworker from Lyndale and will be amended and updated to reflect changes as they occur.

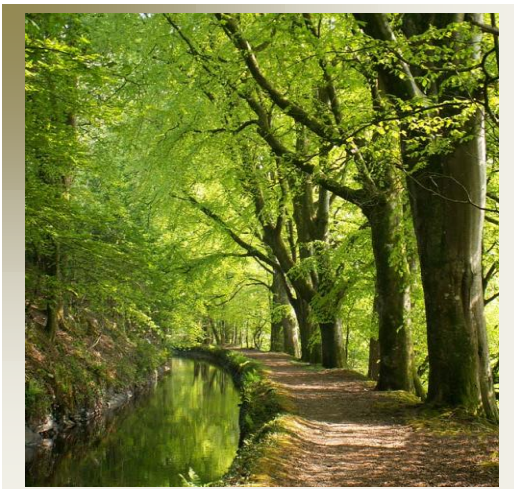
